Greetings

I am writing to formally acknowledge my nomination to participate in the discernment process for the election of the next Bishop for the Diocese of Moosonee. I am honoured to accept this nomination and wish to express my gratitude to all those who have supported me through prayer and candid conversations as I discerned God's call. I am particularly thankful to my wife, Nancy, for her unwavering support as we continue to discern God's call for our lives and ministry. She has also committed to holding me accountable for clergy self-care, as outlined in the "Bishops Care" section of the ministry profile.

Throughout this discernment process, several concerns have been raised that I would like to address to assist the delegates in discerning whom God is calling to the office of Bishop of Moosonee. The concerns include my dyslexia, the decision to reduce my ministry time, and the status of my current medical ability to handle the demands of the office of Bishop. I have provided explanations for these concerns, along with an updated copy of my CV, a response to the Ministry Profile .

Addressing Dyslexia and Communication

The first issue I wish to address is my ability to communicate effectively in writing. During my university years, I was diagnosed with dyslexia, a learning disability. Throughout my academic and ministerial endeavours, I developed learning strategies that have been instrumental to my success. A significant test of these strategies was during my tenure as Bishop Commissary for a previous diocese, where I dealt with a colleague criminally charged with embezzlement. This situation required effective written communication, managing parish and clergy morale, public relations, and navigating criminal court proceedings. The learning strategies served me well, particularly the importance of recognizing one's limitations and seeking expertise when necessary. I am confident that these strategies will continue to support me as I advance in ministry.

Transition to Part-Time Ministry

I would like to explain my decision to transition from full-time to part-time ministry. This decision was made during a challenging period when Nancy and I were managing the care needs of our parents and supporting one of our sons who struggles with mental health issues. This period was taxing on us mentally, spiritually, and financially. To address these demands, I needed to step back, which also allowed the diocese to allocate funding for another position. Whether this was the right decision remains uncertain. However, with my mother's recent passing and having the appropriate support for my son and father-in-law, I am now in a position to assume greater responsibilities.

Current Health Status

Lastly, I wish to address the concerns regarding my current health. As some may know, I was diagnosed which was thought to be a brain tumour . The initial diagnosis was distressing, affecting my ability to drive and manage the stress of the uncertainty. However, with guidance of a the Neurosurgery department of both Sudbury Hospital and Toronto Western Hospital and two follow up MRI 's It's now been diagnosed as low grade small ependymoma benign lesion . In conversation with the doctor's it is their believe I have had this lesion my whole life.

As well I did consult my family doctor n regards to my Mental and Physical wellness to care out the demand of duties the of Bishop Moosonee. After her read of the of section care of Bishop and her investigation she believe I am so fit to carry out duties and demands of Bishop Moosonee. I have included her letter and a copy of the MRI report of Dec 23,2024.

I trust that these explanations will assist the delegates in their discernment process to determine whom God is calling to be our Bishop.

Stable 8 mm intraventricular lesion in the right lateral ventricle. No significant mass effect or perilesional edema. No enhancement.

Flow voids are preserved. Orbits, bones and extracranial soft tissues are unremarkable.

CONCLUSION:

Stable 8 mm lesion in the right lateral ventricle of indeterminate MRI characteristics. No suspicious features. A low-grade lesion is favored, such as an ependymoma.

Response to Diocesan of Moosonee Profile

I would share my commends the Diocesan of Moosonee Profile it lays out a very realistic picture of the dynamic of make up of the Diocese Moosonee. It is clear from the profile that Moosonee Diocese is unique in its geographical and cultural dynamics, although largely comprised of Aboriginal culture but does comprised of other cultures. The Diocese is not without concerns, finanical, Clergy shortages, etc, however these concern are not just unique to us, but are issue and concerns for most Diocese in the Canadian Church. I am impressed with the profile of the Diocese. I will share my thoughts around the profile and will comment on the ministry Profile in another response outlining what I view as the roll of Episcopal ministry in the Diocese of Moosonee.

As I conclude from my review of the Profile of the Diocese we are survivors in many aspects. One thinks of Residential School Survivors which there are people in our Diocese that our survivors of Residential Schools. As a dioceses we are committed to walk the healing road, with its commitment to Healing Gatherings. I would note our approach to the restoration of Old St Thomas Church. We could have just disposed of the building and move on. However our approach to was not move on but form a new relationship with the MRHHA group to restore the the church which provide for us new opportunities to journey with people to move toward healing and to experience the Love Christ in their mist.

Ten year's ago we were confront with the issues of how we as a Diocese continue to exist. We took a step in faith to continue as diocese and embrace understanding of a Area Mission to move forward . The other option was just disbanded and reline with other surrounding Diocese but we chose to remain as one diocese with new way being God's people. The Area Mission may not have been perfect but we survived and grew. It's seems that we found new way of doing ministry, with concept of empower lay ministry (Lay Readers) diaconal ministry, utilizing retired clergy and non Stipendiary clerical ministry which has allowed us to maintain a ministry presence the our communities . A support system was developed with the formation of the Bishop Thomas Corston School of Ministry ,GBD Bible studies etc. I also see a movement from Survival Ministry to Missional Ministry. The approach we took with the Restoration of the Old St Thomas Church and our involvement with Quilts for Survivors and the St Matthew's Cathedral Lunch Ministry and I know there are many other Missional Outreach programs in our Dioceses .

The Diocesan Profile reflected the reality of ministry here the Diocese of Moosonee it laid out the challenges which are unique to us. However we can not over look that we are survivors and we have the ability to adapt to new ways to being able to committed to one another in the journey and moving forward not just surviving but embracing Missional Ministry as key to in meeting our need in the future .

Response to the Ministry Profile for the Diocese of Moosonee

I recognize that the Ministry Profile is the culmination of discussions from the Season of Discernment. I commend the committee responsible for this profile for their excellent work. I concur with the concepts outlined in the profile of the Bishop's Ministry, as they are crucial for the growth of our Diocese, both internally and within the Canadian Church. I was particularly impressed by the commitment expressed in the section "Care of Bishop," which emphasizes the importance of self-care. The role of the Bishop of Moosonee carries significant demands that impact both spiritual and personal well-being. It is essential that the Bishop is held accountable for taking all vacation time, as well as quiet days and retreats, for their own well-being. I appreciate that this was highlighted in the profile.

In response to the Ministry Profile, I find it appropriate to share my brief thoughts on the three questions addressed in the conversation about a Bishop's Ministry.

What image of a Bishop's Ministry speaks to you?

The image of the Bishop as a Good Shepherd resonates deeply with me. This image relates to a pastor for the entire body and calls us into new relationships, which is crucial in the context of a changing church in the twenty-first century. The reality of ministry is not as it once was; we must now adapt to proclaim a Gospel message to a world that needs to hear it, in a manner that maintains integrity within the environment we live in. The image of the Good Shepherd embodies the pastoral importance of embracing the struggles of our time and helps us face the new relationships we must form to share the Gospel message with integrity.

What might be the delights of being the Bishop of Moosonee?

For me, the delight would lie in addressing the challenges we face in the Diocese. The Diocese has begun to transition from survival ministry to exploring new ways of conducting ministry and sharing the Gospel, particularly by building new relationships with our Indigenous peoples. We are in a new and exciting era, both in our Diocese and the Canadian Church, in terms of ministry. It is an absolute joy to be part of that journey.

What might be the challenges?

In addressing this question, I believe there will be numerous challenges the new Bishop will encounter, some of which are not unique to our Diocese but are issues for the entire church, such as clergy shortages and financial constraints. I understand that our Indigenous communities have experienced significant losses during our time as a mission area. It is my understanding that the Bishop's visits to these communities were not solely for liturgical needs but also involved being part of the community for extended periods, fostering a sense of presence. Communication is another challenge for the Diocese; we need to improve how we communicate what is happening in our parishes. During my tenure as Regional Dean, I attempted to address this by implementing Deanery Gatherings, which provided opportunities for prayer, learning, and sharing joys and struggles within our parishes. As well need broaden the understanding of Healing and Reconciliation to what it might look like for the diocese more specifically in the non indigenous parishes, to better enable us to journey together.

Response to the Ministry Profile for the Diocese of Moosonee

The support and mentoring of clergy and lay leaders is an important issue for me. The challenge I would face is how to adapt the principles of the 12-12-12 program to the Diocese, given our financial limitations. There will be numerous challenges, and we must remember that many of these challenges are not unique to us. We need to work as a united front, both at the parish and diocesan levels within the Canadian Church, as we seek solutions for our challenges and, most importantly, maintain our faith as we move forward in ministry.

I hope my approach to responding to the Ministry Profile has been helpful in conveying my understanding of episcopal ministry within the Diocese of Moosonee. I look forward to the opportunity to discuss my thoughts with you. Blessings,
